SUPPLEMENTAL DECLARATION TO THE

SEVENTH AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS TEXAS GRAND RANCH

Pursuant to the Seventh Amended and Restated Declaration of Covenants, Conditions and Restrictions for Texas Grand Ranch, Section 9.3 and as recorded at Instrument Number 64008 in the Official Records of Walker County, in Walker County, Texas, the undersigned hereby amends the Declaration as follows:

The following Section 3.7 Use of Temporary Structures and Sales Offices, is amended to further clarify the intent of the Declarant as it relates to Section 3.7 and shall be replaced its entirety, as follows:

No structure of a temporary character, whether trailer, basement, tent, shack, garage, barn or other outbuilding shall be maintained or used on any Lot at any time as a Dwelling or for any other purpose, either temporarily or permanently; provided however, that Developer reserves the exclusive right to erect, place and maintain such facilities in or upon any portion of the Subdivision as in its sole discretion may be necessary or convenient while selling Lots, selling or constructing Dwellings and constructing other improvements within the Subdivision. Model homes to be constructed by builders must be approved by the TGR ARC.

The Developer may continue, at any time, to maintain a sales office (facilities) in accordance with this Section 3.7 for the sole purpose of property resales within the Texas Grand Ranch Subdivision. The Developer may also choose to provide an office for the Property Owners Association, within these facilities.

Nothing in the Declaration shall be construed as a violation, in regards to the sales office now or in the future. These facilities are further identified as Texas Grand Ranch Section 1, Block 2, Lots 42 & 43.

These terms and conditions of the Declaration shall remain with the Developer and shall be terminated upon the sale of said properties.

All other terms and conditions of the Declaration shall remain the same.
